Whereas, a State of Emergency is hereby declared in the County of Putnam effective at 12:01 a.m. on January 25, 2026.

Whereas, this State of Emergency has been declared due to the forecasted severe winter weather conditions, including significant amounts of snow and ice resulting in extensive travel disruption, property damage and extremely hazardous road conditions throughout Putnam County.

Whereas, the effects of heavy snow and ice conditions precipitated by such anticipated winter storm will make traversing certain roadways within the County dangerous and/or impassable. Such conditions threaten or imperil the public safety of the citizens of Putnam County, New York. Putnam County will therefore be under a State of Emergency. During this time, the County will take all required and necessary steps in order to address the damage and ensure the safety of all travelers and residents.


Whereas, this State of Emergency will remain in effect for thirty (30) days or until rescinded by a subsequent Order.
